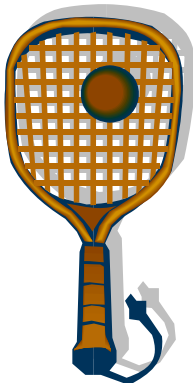

Rules: Matches are two games to fifteen points with an eleven point tie breaker.

Check-in time is 30 minutes prior to starting time.

The ten (10) minute forfeit rule will be enforced.

Winners will be required to referee or forfeit their win. Both winning doubles partners must referee if needed. Tournament Director may reclassify players according to level approved. Division format is subject to change dependant on number of entries.

Please Note: Doubles level determined by highest level player. Divisions with less than eight entrants may be canceled or combined. Contestants entered in two events will be required to play back to back matches.
